# B. Old Business:

1. Upon the recommendation of Susan Reese, Harold Haralson moved, seconded by Darry Stacy, to table until a later date the awarding and/or rejecting of bids for Bid **#HWY -1918** – Six month (6) Non-Encumbered Contract for Tires and Tubes. The bid term will be from September 5, 2019 through March 4, 2020. The vote was: Darry Stacy, yes; Rod Cleveland, yes; Harold Haralson, yes. Motion carried.

### C. Items of Business:

Chairman Harold Haralson said that the following Items, No. 1 through No. 8, are **Consent Items** and are routine in nature: Darry Stacy moved to **approve** the Consent Items. Rod Cleveland seconded the motion:

1. Application STOP Violence Against Women Act Grant 2020-2021 to fund a Court Service Officer position to supervise offenders convicted of domestic

violence. This position allows for probation term instead of incarceration in the County Jail. A grant application has been previously approved 2004 - 2019, the County does not provide any matching funds.

- 2. Maintenance Agreement between Board of County Commissioners on behalf of Cleveland County Purchasing Department and Standley Systems effective July 1, 2019 through June 30, 2020 in the amount of \$0.0080 for b/w pages and \$0.005 for color, monthly.
- 3. Lease Purchase Agreement between Board of County Commissioners on behalf of Cleveland County District 1 and Warren Cat effective August 2019 through August 2023 in the amount of \$4,002.36 per month for a 2019 CPP56B Vibrating Padfoot Roller.
- 4. Rescend and Reapprove previously approved contract between Board of County Commissioners on behalf of Cleveland County District 1 and Del Nero Communications Management, LLC effective July 1, 2019 through June 30, 2020 in the amount of \$1,320.00.
- **5. Resolution for Disposing** of the following items from the Cleveland County Court Clerk's Office. These items were traded.
  - a. Printer, J220-572
  - b. Fax machine/Copier/Scanner, L218-345
  - c. \*Rigid Crimp Tool, SM 359-3 Dispose of duplicate inventory item (Clerk's Note: \*Item "c" is for Building Maintenance.)
- 6. Notice of Appointment of Receiving Officer for the Cleveland County Sheriff Department naming Amyee Knipping, replacing Amyee Williams, on all Sheriff Department Accounts.
- 7. Review, Audit, and Approve or Disallow Blanket Purchase Orders submitted. A report will be available for distribution at the meeting or may be obtained from the County Clerk.
- 8. Review, Audit, and Approve or Disallow claims for Payment of Personal Services, Travel, Maintenance & Operations, and Capital Outlay. A report will be available for distribution at the meeting or may be obtained from the County Clerk.

D. Under "New Business", Chairman Haralson said that he put some forms on his fellow Commissioners' desks and has discussed this with Assistant District Attorney Jim Robertson who recommended bringing this item before the Board for approval. He met with Sam Coval, Department of Transportation, earlier this morning along with Laura Smith, GIS, concerning a meeting they had last year about some inaccuracy in the number of road miles being short by about ten miles. As a result of the meeting, Mr. Coval is going to make some corrections to give Cleveland County

the additional road miles. The form is ready for the Board's approval in authorizing the change.

Rod Cleveland made a motion to approve the form. Darry Stacy seconded the motion.

E. During Commissioner's discussions about County Business, Rod Cleveland said that he is working on some legislation for next year and he sent it to a few County Commissioners and legislators that are changing the language. Instead of saying ODOT telling us what our routes are that by statute the Board of County Commissioners every two years notify or give notice to ODOT the number of certified road miles. So far, the response to his new legislation is very positive. He discussed the advantages offered by NACo, National Association of Counties that has a Healthy Living Prescription Program that is free for member counties and provides discounts on prescriptions.

Darry Stacy asked for prayers for the victims of violence over the weekend.

Harold Haralson said he agrees with Commissioner Stacy and added it points to the issues that this country is experiencing in mental health.

Chairman Haralson commended Laura Smith for all her hard work on the GIS System.
