

BOARD OF COUNTY COMMISSIONERS

MONDAY, SEPTEMBER 9, 2019

John Roberts led in Prayer and Pledge of Allegiance.

Chairman Harold Haralson called to order the regularly scheduled meeting of the Board of Cleveland County Commissioners at 1:00 P.M. this 9th day of September 2019 in meeting Room 200 of the Cleveland County Office Building. Tammy Belinson, County Clerk/Secretary, called roll and those present were:
