Chairman Harold Haralson called to order the regularly scheduled meeting of the Board of Cleveland County Commissioners at 1:00 P.M. this 16th day of September 2019 in meeting Room 200 of the Cleveland County Office Building. B. Items of Business:

- C. There was no new business to come before the Board for discussion.
- D. During Commissioner's discussions about County Business, Commissioner Darry Stacy expressed his condolences to the Sheriff's Department for the loss of one of their deputies and stated that the tremendous outpouring of sympathy from the community was gratefully received. He gave the Norman Police Department a well-deserved thank you for their services. Commissioner Stacy offered his heartfelt sympathy to the family.

Commissioner Cleveland reiterated Commissioner Stacy's condolences to the family. He reported on his conversation with OG&E Community Affairs Manager Tom McCurdy about the power outages the courthouse experienced recently causing the building to close. He requested their help in selecting a generator powerful enough to keep the courthouse from being without power again. He said they responded obligingly to assess the situation at the County Office Building.

Commissioner Cleveland said that by statute the Board is to approve a Five Year Plan by September 30, 2019 for any projects and wanted to make sure that he had not missed those.

Darry Stacy said he will check on that.

Chairman Haralson expressed his condolences to the Sheriff. He pointed out the power outages have been a concern for many years and discussed by the Downtown Business Association and the Norman City Government and the situation remains the same as it is today. His personal thoughts are that it is an unhappy situation and that the county should go ahead with plans to buy a generator due to safety concerns.

Chairman Haralson counselled fellow Board member to not post on Facebook on things not voted on by the Board. He said that as an individual, a Commissioner cannot speak on behalf of the county without the Board's approval.

E. Kathleen Hallren made a **Public Comment** about placing Sunday opening of Retail Licensed Spirits Shops allowed by statute on the next general election ballot by a motion of the County Commissioners. There are thirty-one stores in Cleveland County and half of those are in Norman and if only ten of those stores decided to stay open that time they would produce \$26,000 more in sales tax for the city, state and a small amount to the county. She estimated an increase in wages for \$83,000.00 per

year. She recommended going forward in placing that on the ballot for election next spring.

F. There being no further business to come before the Board, Rod Cleveland moved that the meeting be **adjourned** at 1:13 pm. Darry Stacy seconded the motion. The vote was: Harold Haralson, yes; Darry Stacy, yes; Rod Cleveland, yes. Motion carried.
