

BOARD OF COUNTY COMMISSIONERS

MONDAY, DECEMBER 30, 2019

Undersheriff Blake Green led in Prayer and the Pledge to Allegiance.

Chairman Harold Haralson called to order the regularly scheduled meeting of the Board of Cleveland County Commissioners at 1:00 P.M. this 30th day of December 2019, in meeting Room 200 of the Cleveland County Office Building. Tammy Belinson, County Clerk/Secretary, called the roll and those present were:
