

BOARD OF COUNTY COMMISSIONERS

MONDAY, FEBRUARY 24, 2020

Sheriff Todd Gibson led in prayer and the Pledge of Allegiance.

Chairman Harold Haralson called to order the regularly scheduled meeting of the Board of Cleveland County Commissioners at 1:00 P.M. this 24th day of February 2020, in Meeting Room 200 of the Cleveland County Office Building. Tammy Belinson, County Clerk/Secretary, called the roll and those present were:
