

BOARD OF COUNTY COMMISSIONERS MINUTES

MONDAY, AUGUST 10, 2020

This Regular meeting was conducted under 25 O.S §306 (C) (Signed and enacted March 18, 2020). The meeting took place in the Board of County Commissioners Meeting Room and through teleconference. Commissioner Rod Cleveland led in Prayer and Pledge of Allegiance.

Chairman Darry Stacy called to order the regularly scheduled meeting of the Board of Cleveland County Commissioners at 1:00 P.M. this 10th day of August 2020, in Meeting Room 200 of the Cleveland County Office Building. C. Items of Business:

1. George Mauldin, Emergency Management Director, presented the following COVID-19 updates and Operations within Cleveland County There are 3,017 confirmed cases in Cleveland County with 55 deaths. This is an increase of 292 cases with six additional deaths since the last weekly update on August 3, 2020.

There are 1,477 cases in Norman with 31 deaths. This is an increase of 122 cases with two additional deaths since the last weekly update on August 3, 2020.

The majority of the new cases are in younger people.

At present, 68.53% of total confirmed cases are among people under 50 years old (up from 68.42%)

The rate of growth in new cases has declined. We averaged 46.2 new cases per day during the first ten days of August. We averaged 79.5 new cases per day during the last ten days of July.

Deaths are increasing slightly but have remained relatively low, with 54 deaths recorded in the past week statewide (44 at last update).

Hospitalizations remain high but have decreased since my last report. As of July 31, there were 498 individuals hospitalized with COVID-19 (218 in the ICU). This is a decrease of 20 since my last weekly report on July 31; (498 hospitalizations with 218 in the ICU). Hospitals are not in danger of being overwhelmed. There are 20% (206) of ICU beds available and 22% (1,349) medical/surgery beds available.

The low point of hospitalizations statewide was 63 on May 18.

As of August 6, Cleveland County is in the "low risk" category on the COVID-19 Alert System with 13.64 cases per 100,000 populations (19.98 on July 30). The threshold for the "moderate risk" category is 14.39. There are 23 counties in the moderate risk category, down from 32 and one county (Cimarron) in the "normal risk" category, the same as the previous week. The remaining 53 counties are in the low risk category.

Harmon County has the "highest" number of cases per 100,000 at 69.71. The numbers used in the COVID-19 Alert System are based on a 7 day rolling average of new cases.

Recommendations are to continue to follow the CDC guidelines on social distancing, sanitation and hygiene.

2. Presentation was made by Carrie Davis on Pre-Trial.

Chairman Darry Stacy said that the following item numbers, 3 through 9, are **Consent Items** and are routine in nature: Rod Cleveland moved, seconded by Harold Haralson, to **approve** the consent items with the exception of Item No. 5 which will be taken separately:

- 6. Approve Renewal of County Bid #PA-1871 with Admiral Express-Office Supplies, Furniture and Equipment for another year. All terms and conditions will remain the same. The renewal period will be from August 31, 2020 through August 30, 2021.
- 7. Jail Services Agreement between Board of County Commissioners on behalf of Cleveland County Sheriff's Office and the City of Moore effective July 1, 2020 through June 30, 2021 in the amount of \$52.00 per day for each person incarcerated.
- 8. Review, Audit, and Approve or Disallow Blanket Purchase Orders submitted. A report will be available for distribution at the meeting or may be obtained from the County Clerk.
- 9. Review, Audit, and Approve or Disallow claims for Payment of Personal Services, Travel, Maintenance & Operations, and Capital Outlay. A report will be available for distribution at the meeting or may be obtained from the County Clerk.

Discussion was had on Item No. 5 to add a signature line for Jackie Kanak, Cleveland County Administrator to the Contract.

Rod Cleveland moved to approve the Contract between Cleveland County Health Department and Cleveland County Healthy Living Block (The Well) effective September 31, 2020 through September 1, 2021, on the contingency that it is signed by Ms. Kanak. Harold Haralson seconded the motion.

The vote was: Rod Cleveland, yes; Harold Haralson, yes; Darry Stacy, yes. Motion carried.

- D. There was no new business to come before the Board for discussion.
- E. Commissioner's discussions about County Business began by welcoming Commissioner Harold Haralson back after forced isolation due to COVID19 exposure. Commissioner Haralson said that he did have one comment to make that he finds it very alarming that the information for the numbers of Cleveland County is not as accurate as he would like for them to be as far as the COVID19 numbers. He finds that concerning because it is hard to make decisions going forward when the information provided is false.

Chairman Stacy said that George Mauldin is working on that.

Mr. Mauldin said that the last information he received the numbers are correct.

District #2 Commissioner Darry Stacy reported on a phone conversation he had with a citizen of Cleveland County to let him how much they appreciated the great job that the Sheriff's Department did by responding quickly to handle a matter around the Slaughterville's area and their professionally coordinated effort with Noble.

- G. There being no further business to come before the Board, Rod Cleveland moved, seconded by Harold Haralson, that the meeting is **adjourned** at 1:15 P.M. The vote was: Harold Haralson, yes; Darry Stacy, yes; Rod Cleveland, yes. Motion carried.
