

BOARD OF COUNTY COMMISSIONERS MINUTES

MONDAY, AUGUST 31, 2020

This Regular meeting was conducted in accordance with 25 O.S §306 (C) (Signed and enacted March 18, 2020). The meeting took place in the Board of County Commissioners Meeting Room and through teleconference. Public comment was made by calling (405)366-0200 to be added to the list.

Commissioner Rod Cleveland led in prayer and the Pledge of Allegiance.

Chairman Darry Stacy called to order the regularly scheduled meeting of the Board of Cleveland County Commissioners at 1:00 P.M. this 31sth day of August 2020, in Meeting Room 200 of the Cleveland County Office Building. Linda Atkins, Deputy County Clerk/Secretary, called the roll and those present were:

B. Old Business:

- 1. C. Items of Business:

1. George Mauldin, Emergency Management Director, presented the following COVID-19 Updates and Operations within Cleveland County.

As of today, there are 3,930 (3,543) confirmed cases in Cleveland County with 64 (63) deaths. This is an increase of 387 (328) cases with one additional death since the last weekly update on August 24, 2020.

There are 1,899 (1,712) cases in Norman with 34 (34) deaths. This is an increase of 187 (153) cases with no additional deaths since the last weekly update on August 24, 2020.

There are 572 (431) active cases in Cleveland County, an increase of 141 and 256 (180) active cases in Norman, an increase of 76.

The rate of growth in new cases was declining but is now increasing. We averaged 45 new cases per day during the first week of August, 30 new cases per day during the second week of August, 45 new cases per day during the third week and 55 new cases per day the last week of August.

Deaths continue to increase slightly but have remained relatively low, with 70 deaths recorded in the past week statewide (65 at last update). We had only one death recorded in Cleveland County during the past week/

Hospitalizations remain high and have increased since my last report. As of August 28, there were 494 individuals hospitalized with COVID-19 (203 in the ICU). This is an increase of 31 since my last weekly report (August 21 report, 463 hospitalizations with 227 in the ICU). The seven day rolling average is 474 (462). Hospitals are not in danger of being overwhelmed.

There are 18% of ICU beds available and 20% medical/surgery beds available.

As of August 27, Cleveland County is in the "low risk" category on the COVID-19 Alert System with 10.41 cases per 100,000 population (12.98 on August 20). The threshold for the "moderate risk category is 14.39. There are 38 counties in the moderate risk category, up from 30 and one county (Ellis) in the normal risk category, the same as the previous week. The remaining 38 counties are in the low risk category.

Cimarron County again has the highest number of cases per 100,000 at 80.22 (population 2,137, 14 total cases).

The numbers used in the COVID-19 Alert System are based on a 7 day rolling average of new cases.

Classen Urgent Care now has the ability to perform rapid point of care PCR tests for COVID-19.

This test requires only 15 minutes to return results and is extremely accurate. A nasal or throat swab is needed for this test.

At present, Classen Urgent Care can perform 100 tests per day at the Norman location and 50 tests per day at the Moore location.

Because of the relatively limited number of available tests, patients with symptoms will be prioritized.

The rapid test may be available to individuals without symptoms depending upon case load at the time.

He recommended that they continue to follow the CDC guidelines on social distancing, sanitation and hygiene and follow the recommendations in the Public Health Advisory issued by Commissioner Frye.

Commissioner Haralson commented that one seasonal flu case has appeared and recommended that everyone get their flu shots. He said symptoms of the COVID and the Flu are much the same and will cause confusion.

Rod Cleveland said that the number of 281,300 represents Cleveland County Citizens that were not affected by COVID. He said the perspectives of those numbers are missed sometimes. He said that last Friday, he was contacted by another County Commissioner that got an email from his regional multicounty Health Department Director that stated that the Health Department starts using the antigen tests results and fold them into the current data and statistics going back to March and those were always listed as probable because they weren't as accurate and they weren't included. Commissioner Cleveland spoke with Jackie Kanak, Cleveland County Department, about the reporting to John Hopkins; most of the States are submitting their information to John Hopkins because they are the depositor of the statistics on COVID, and Oklahoma was not included in the antigen tests. Ms. Kanak said our numbers will spike, but there will be an explanation of why that happened. He expressed concern that some people will use the spike to cause fear rather than look at it as a statistic.

Chairman Darry Stacy said that the following item numbers, 2 through 10, are **Consent Items** and are routine in nature: Rod Cleveland moved, seconded by Harold Haralson, to **approve** the consent items.
