MONDAY, SEPTEMBER 28, 2020

B. Items of Business: Discussion, Consideration and/or Action regarding the following:

 George Mauldin, Emergency Management Director, presented the following COVID-19 Updates and Operations within Cleveland County.
 As of today, there are 6,063 (5,620) confirmed cases in Cleveland County with 70 deaths. This is an increase of 443 (618) cases with two additional deaths since the last weekly update on September 21.

There are 3,256 (3,034) cases in Norman with 36 deaths. This is an increase of 222 (649) cases with one additional death since the last weekly update on September 14, 2020.

There are 837 (892) active cases in Cleveland County, a decrease of 55 (-53) and 422 (490) active cases in Norman, a decrease of 68 (-149).

The number of deaths has increased in the past week with 59 deaths recorded in the statewide up from 43 at last update. There were two deaths recorded in Cleveland County during the past week.

Hospitalizations are also up. As of September 25, there were 496 individuals hospitalized with COVID-19 (206 in the ICU). This is an increase of 42 since my last weekly report (September 18, 454 hospitalizations with 215 in the ICU). The seven day rolling average is 508, up from 449 on September 18.

Hospitals are not in danger of being overwhelmed but available resources have decreased. There are 13% of ICU beds available down from 17% last week, and 19% of medical/surgery beds available, the same as last week.

As of September 24, Cleveland County is in the "orange" or moderate risk category with 28.0 new cases per 100,000 population, down from 29.02 on September 17.

Harmon County is the only county in the normal (green) category, there 17 counties in the low (yellow) category and the remaining 59 counties are in the moderate (orange) category.

Woodward County has the highest rate in the state with 587.4 new cases per 100,000 population. Woodward County has a population of 20,211 and a total of 1,059 cases with 98 cases in the past week.

As of September 25, there were a cumulative total of 2,574 (1,978 on 9/18) cases and 11 deaths in correctional facilities including prisons, jails and juvenile detention centers. Of these, 2,177 cases and 9 deaths were among inmates, the remaining 397 cases and 2 death were staff members. 1,079 of these cases are in DOC facilities. DOC also reports 1,167 test results pending.

The cumulative total at the Lexington prisons is 394 inmates and 47 staff members. There have been 3 deaths related to COVID-19 among inmates. Most of these individuals have recovered. As of September 25, there were 29 inmates and 5 staff members with active infection in the Lexington prisons.

The Oklahoma Department of Corrections now declares a facility a "hot zone" when a facility or specific unit within a facility has at least 20% of inmates test positive within a celled housing unit or at least 15% of inmates test positive within an open bay housing unit. Joseph Harp is designated as a hot zone.

At present, we have 28 inmates and 4 staff members who are positive for COVID-19 in our jail.

Norman Public Schools has begun a three phase process to resume in-person classes. All three learning options, traditional, blended and virtual will continue to be offered. However, students who are enrolled in the traditional learning option will be phased back into school buildings over the next three weeks, as outlined below.

Sept. 28 - Oct. 2

- Elementary students will return to full-time, traditional instruction.
- Middle school students will return to school on an alternate schedule.
- High school students will continue following the remote learning schedule.

Oct. 5 - Oct. 7

- *There is no school Oct. 8-9 due to fall break.
- Elementary students continue full-time, traditional instruction.
- Middle school students will return to full-time, traditional instruction.
- High school students will return to school on an alternate schedule.

Oct. 12 - Oct. 16

• All students will report to school for full-time, traditional instruction.

After the phase-in process is complete, students will continue following a full-time schedule unless the Oklahoma COVID-19 Alert System reports Cleveland County in the red level.

Classen Urgent Care began performing rapid PCR tests on August 31. Since that date, they have performed 2,605 rapid tests, of which 444 were positive. This is a positivity rate of 17.04% (17.13%).

Recommendations:

Re-open the gym effective immediately with these precautions:

Limit capacity to six people at a time,

Deactivate every other cardio machine upstairs to ensure proper distance is maintained.

Disinfecting commonly touched surfaces at least twice daily,

Ensure adequate supplies of disinfecting wipes are available at all times.
