CLEVELAND COUNTY

The Board of County Commissioners of Cleveland County has adopted Executive Order 2020-20 filed by the office of Governor Stitt on November 16, 2020, therefore:


Effective November 18, 2020, and except as otherwise provided below, all persons on property including buildings and office space owned or leased by Cleveland County shall wear a facial covering or mask over the mouth and nose at all times where physical distancing measures may be difficult to observe. This only applies to persons while indoors or when in an outdoor space, wherever it is not feasible to maintain six feet of social distance from another person. Facial coverings or masks are not required in the following circumstances:

- a. In county owned and leased vehicles, if only occupied by one occupant;
- b. When a person is alone in an enclosed space;
- c. When the individual has a bona fide religious objection to wearing a facial covering or mask;
- d. While eating or drinking;
- e. When a licensed healthcare provider has determined that wearing a facial covering or mask causes or aggravates a health condition for the individual;
- f. When wearing a facial covering or mask would prevent the receipt of services or performing work in the course of employment;
- g. When complying with the directions of law enforcement or for the purposes of verifying a person's identity; and
- h. Children under the age of 10.

Reusable cloth face coverings are available for employees at the Office of Emergency Management.

Disposable masks will be available at the doors for visitors.

Adopted this 17th Day of November by the Board of County Commissioners, Cleveland County.




