Chairman Stockwell introduced Beth Stanley with the District Attorney's Office. Ms. Stanley will be our person to try and supervise and make some sort of sense out of Community Sentencing.

Chairman Stockwell called for presentation on Status Report from Oklahoma Court Services, Inc., and Wayne Barnes.

Julia Curry introduced Tina Potts and she will be coming to the Community Sentencing Meetings and providing the support that the Council needs. At the present time Oklahoma Court Services is supervising community service and Wayne Barnes is in the process of getting Ms. Curry the exact amount of hours the clients have outstanding. Discussion took place on the caseload that Mr. Barnes has and how many more clients the Council has to have before some of the clients are given to Oklahoma Court Services and how the newly elected District Attorney would help Community Sentencing.

Chairman Stockwell asked Dorinda Harvey, County Clerk, about the newly elected District Attorney and the newly elected County Commissioner and what procedure the Council would need to do to make them part of this Council.

Ms. Harvey stated the new District Attorney is automatically on the Council and the Board of County Commissioners will appoint through their meetings a Commissioner to be on the Council.

Questions were asked about the GPS Monitoring, there are 5 bracelets but there haven't been any of the bracelets used lately. Chairman Stockwell stated the Council would lose the 5 bracelets along with all the others county wide, if clients are not put on them and discussion took place.
