Chairman Stockwell called for the review Status on Bench Warrant Executions and Arrest of Absconders.

Mr. Brinkley stated the absconders stayed the same. Mr. Brinkley also stated there were 2 people currently in Jail. One being Virgil Green with new charges and still pending motion to revoke the Community Sentencing Program. Second one being Shannon Osborn with motion to revoke the Community Sentencing Program.

Chairman Stockwell called for the presentation on Status Report from Bobby Brinkley.

Mr. Brinkley stated they have not changed on their case load size. Still staying around 42 – 43 and same type of cliental they have been receiving. Sanctions have been averaging the same every month; they have not gone up or down. Mr. Brinkley stated the count will go up this month with the new cliental coming in.

Chairman Stockwell asked if they used incentives very much?

Mr. Brinkley replied yes.

Judge Hetherington explained how the incentives were earned and worked.

Discussion took place.

Chairman Stockwell called for miscellaneous discussion.

Carmen Jackson stated on Wednesday they would be starting their new UA System. Ms. Jackson went on and explained how the testing would take place and their cost.
