

COMMUNITY CORRECTIONS PLANNING COUNCIL

MINUTES

JULY 12, 2016

The regularly scheduled meeting of the Community Corrections Planning Council was called to order at 8:30 am this 12th day of July 2016 in the Conference Room 200 of the Cleveland County Office Building by Chairman Dave Stockwell. Linda Atkins, Deputy County Clerk/Secretary, called roll and those present were:

Others present were: Linda Atkins, Debi Cox, Rachel Rogers, Bobby Brinkley and Paul Garcia.

Chairman Dave Stockwell asked if the meeting complied with the **Open Meeting Act**. Linda Atkins answered affirmatively.

After the reading of the minutes of the Regular Meeting of April 12, 2016 and there being no additions or corrections, Waldo Blanton moved that the minutes be **approved**. Sheriff Joseph Lester seconded the motion.

The vote was: Dave Stockwell, abstain, Woody Glass, yes; Sheriff Joseph Lester, yes; Waldo Blanton, yes; Greg Mashburn, yes; Darry Stacy, abstain; Judge Jeff Virgin, yes. Motion carried.

A. Items of Business:

1. Dave Stockwell moved, seconded by Waldo Blanton, to **approve** using up to **\$3,000 of 210 Administrative Fee Funds for incentive items** such as but not limited to grocery gift cards, gas cards, turkeys for the holidays, AA/NA recognition items, GED testing fees, dinner gift certificates, amusement venues, bus passes or other pro-social incentive items for **fiscal year 2017**.

The vote was: Dave Stockwell, yes; Woody Glass, yes; Sheriff Joseph Lester, yes; Waldo Blanton, yes; Greg Mashburn, yes; Darry Stacy, yes; Judge Jeff Virgin, yes.

Motion carried.

2. Dave Stockwell moved, seconded by Waldo Blanton, to **approve the Community Sentencing Supervision Officer cell phone invoice** to be paid out of the 210 Administrative Fee Funds for **fiscal year 2017**.

The vote was: Dave Stockwell, yes; Woody Glass, yes; Sheriff Joseph Lester, yes; Waldo Blanton, yes; Greg Mashburn, yes; Darry Stacy, yes; Judge Jeff Virgin, yes.

Motion carried.

3. **Debi Cox discussed the Review of bills** for the months of April, May and June 2016. (A copy is attached hereto and made part of these minutes.)

The vote was: Dave Stockwell, yes; Woody Glass, yes; Sheriff Joseph Lester, yes; Waldo Blanton, yes; Greg Mashburn, yes; Darry Stacy, yes; Judge Jeff Virgin, yes.

Motion carried.

At this point, Chairman Stockwell called for discussion on Item No. 5.

5. Bobby Brinkley stated during his presentation and **Review Status on Bench Warrant** Executions, Arrest of Absconders and Status Report that there are new people in their first month in the program. There are a few no shows. Overall, they are doing well on absconders.

Greg Mashburn asked when these guys don't show up do they ever get those people back on track. He asked do they only decide to get serious after getting caught.

Bobby Brinkley said that some of them get on track; it's about fifty/fifty.

Greg Mashburn asked if they use the excuse of not understanding the process for absconding.

Bobby said that they usually say they got scared and decided to not show up or they will say the pressure was on them. He said there is no excuse because it is not hard.

Greg Mashburn asked if he attended the sentencing.

Bobby Brinkley said that he attends a lot of the times. For the most part, the ones that don't show up are in jail in other counties.

Chairman Stockwell asked if Bobby Brinkley ever contacted their defense attorney.

Bobby Brinkley said that the defense attorney never has much information on them. He said that the Pre-Sentencing Program has helped a lot.

Paul Garcia said that it often teaches them to know what to expect if they plea in or not.

Chairman Stockwell asked how often they meet for Community Sentencing Docket.

Assistant District Attorney Rachel Rogers said they meet twice a month because they split it between the names beginning with A-K and L-Z.

Paul Garcia said they have weekly staff meetings.

1. **P.O.** repeatedly attempts to contact the client by mail, telephone, and in person by conducting home visits/for approximately 30 days.
2. **P.O.** Checks local jails and hospitals.
3. **P.O.** contacts family, friends and employers requesting them to pass along the message to contact their **P.O.**
4. After 30 days, **P.O.** files a violation report to the Court requesting that a warrant be issued due to the fact that the client has gone **AWOL**.
5. **P.O.** confirms that the active warrant has been posted in **NCIC**. If it is not posted, **P.O.** writes a letter requesting that the warrant be entered into **NCIC**.
6. Quarterly, **P.O.** requests additional **NCIC** reports to ensure that the client has not been arrested in another town or state.

EALEY, DAVID-CF-15-1559-Absconder-Warrant issued on 4/2/16, 209 Cedar Lane in Moore, OK

GIBSON, EDWARD – CF-14-482-Absconder-Warrant issued on 7/8/15, 6000 96th St. in Noble (Grandmother's & mother address) *he was living in shack directly behind the house

GALARNEAU, JONATHAN-CF-2015-1701 – Absconder – Warrant issue on 6/9/16 – no known address – last known address is invalid.

JENNINGS, DAVID – CF-2012-1165, 2013-1782 – **ABSCONDER** – Warrant issued on 12/1/15 – no known address – walked away from CAAIR Treatment.

REESE, DANIEL – CF-2013-1551 – Absconder – Warrant issued on 5/26/16 – Last known address invalid – Received information he has gone to Colorado.

ROACH, THOMAS – CF-12-134 – Absconder – Warrant issued on 1-13-16 – 917 NW 24th Apt 149 in Norman, OK

SHATSWELL, LANCE – CF-16-243 – Absconder – Warrant issued on 6/9/16 – No known address – never reported into office after being sentenced.

SHIPLEY, CRAIG – CF-12-0519 – Absconder – Warrant issued on 4/20/16 – 3525 SW 22nd in OKC, OK

4. Presentation made by **Assistant District Attorney Rachel Rogers** on April, May and June 2016 activity of Community Sentencing in the District Attorney's Office, reported that there were twenty-one (21) LSI Orders and six (6) people pled into the program. She said that Assistant District Attorney Thomas Sasser will come on board and he would be here today but this was his day off.

Chairman Stockwell said that Thomas Sasser will do a great job.

B. There was no **new business** to come before the **Board** for discussion.

C. During Council Members discussions regarding Community Correction Business, Chairman Stockwell said the Board shall elect a Vice-Chair at the next meeting scheduled for October 11, 2016 at 8:30 a.m.


