

COMMUNITY CORRECTIONS PLANNING COUNCIL

MINUTES

JANUARY 10, 2017

The regularly scheduled meeting of the Community Corrections Planning Council was called to order at 8:30 am this 10th day of January 2017 in the Conference Room 200 of the Cleveland County Office Building by Chairman Dave Stockwell. Linda Atkins, Deputy, representing County Clerk/Secretary, called roll and those present were:

Others present were: Debi Cox, Rachel Rogers, Bobby Brinkley and Paul Garcia.

Chairman Dave Stockwell asked if the meeting complied with the **Open Meeting Act**. Linda Atkins answered affirmatively.

After the reading of the minutes of the Regular Meeting of October 11, 2016 and there being no additions or corrections, Waldo Blanton moved that the minutes be **approved**. Greg Mashburn seconded the motion.

The vote was: Dave Stockwell, yes; Waldo Blanton, yes; Greg Mashburn, yes; Darry Stacy, yes; Linda Atkins, yes.

Motion carried.

A. Items of Business:

1. Dave Stockwell moved, seconded by Waldo Blanton, to adopt and approve the FY **2018 Plan** and Budget Request.

Motion carried.
2. **During Review of bills** for the months of October, November and December 2016, Debi Cox said that we are comparatively low at this time with thirteen in the program. There are more needing to plead in.

3. **Chairman Stockwell said that presentation by Assistant District Attorney** on October, November and December 2016 activity of Community Sentencing in the District Attorney's Office is moved to the end of the agenda.
4. **Presentation and Review Status on Bench Warrant** Executions, Arrest of Absconders and Status Report from Bobby Brinkley:

Bobby Brinkley said that not much has changed. It has been the same story they are the ones that are high on the LSI scores they just disappear immediately after their sentencing. Absconders; we are doing well. It looks like a lot on there but I think overall it is going great.

Chairman Stockwell asked if he needs the Sheriff to assist with the absconders.

Bobby Brinkley said the ones that are listed do not have valid addresses.

Chairman Stockwell said that he hopes that no one is on the list when they meet again in the next three months.

Bobby Brinkley commented on Melissa Johnson who is doing a special project called "Clean Life. Clean Home". It is nonprofit, as a way to pay it forward to other addicts in recovery. She will choose one person in recovery a month, to share their story on social media for others to see recovery is possible and she and others will go in and clean their home one time for free.

Chairman Stockwell asked Bobby Brinkley to discuss the tax exempt status of the 501(c)(3) with Sheriff Joseph Lester since she is receiving donations.

Bobby Brinkley affirmed that he will do so.

3. **Chairman Stockwell called for presentation by Assistant District Attorney:**

Rachel Rogers reported on October, November and December 2016 activity of Community Sentencing in the District Attorney's Office, that there were 25 LSI Orders and 5 have pled into the program since October.

B. No new business to report at this time.

C. There were no Council Members Discussions regarding Community Correction Business.

D. No comments from the public were made.

E. There being no further business to come before the Board, Waldo Blanton moved that the meeting be **adjourned at 8:39 am.** Sheriff Joseph Lester seconded the motion. 
