3. **Assistant District Attorney** Thomas Sasser presented on the October, November and December 2018 activity of Community Sentencing in the District Attorney's Office. He said that seven people were sentenced into the program and did a total of seven LSI's. There are a few waiting to plea in and stated that he is satisfied with the numbers at this time which is sitting at 67.

4. Chairman Stockwell called for the **Supervision overview and absconder status report** by Court Related Services and DOC Officer Dawn Thatcher.

Dawn Thatcher said she had nothing to report at this time.

Paul Garcia said they are still attempting to locate eleven people who have absconded by checking the jail rosters and the arraignments lists.

Chairman Stockwell asked why they don't make notations on the warrants that are issued to not bond them until they find out where they are, that way they can't get back on the street and disappear.

Chairman Stockwell asked if they knew when these absconders pled in.

Paul Garcia said he knows, but the information is not with him today and will provide that at the next meeting.

Chairman Stockwell asked if the Sheriff has a list of this, as well as, the United States Marshalls.

Mr. Garcia said the Sheriff has the list.

C. No **new business** to report at this time.

D. Discussions by **Council Members** about **Community Correction Business** concerned the status of Council Members Waldo Blanton and Woody Glass. Chairman Stockwell said that he will contact both of them to see if they want to stay on as Council Members. He said that they need a full nine member body and if they do decide to resign then he will officially accept their resignations over the phone and from that point figure out who gets to pick the two new replacements. He will encourage them to attend meetings on a more regular basis if their decision is to continue as Council Members.

E. No **comments** from the **public** were made.

F. There being no further business to come before the Board, Dave Stockwell moved that the meeting be **adjourned** at 8:39 am. Greg Mashburn seconded the motion.
