

COMMUNITY CORRECTIONS PLANNING COUNCIL

MINUTES

TUESDAY, JULY 09, 2019

The regularly scheduled meeting of the Community Corrections Planning Council was called to order at 8:30 am this 9th day of July 2019 in the Conference Room 200 of the Cleveland County Office Building by Chairman Dave Stockwell. Tammy Belinson, Deputy County Clerk/Secretary, called the roll and those present were:

Dave Stockwell, Chairman Darry Stacy, Vice-Chairman Tammy Belinson, Secretary Sheriff Todd Gibson, Member Greg Mashburn, Member Judge Jeff Virgin, Member Woody Glass, Member

Ed Copelin, Member, was absent.

Deborah Cox said that Waldo Blanton's son sent regrets to the committee via email that Mr. Blanton cannot continue as a member due to his health and asked that his resignation be accepted immediately since Mr. Blanton is unable to write a formal letter.

Others present were: Linda Atkins, Greg Stroud, Madison Stockwell Clark, Travis White, Thomas Sasser, Deborah Cox, Dawn Thatcher and Paul Garcia.

Chairman Dave Stockwell asked if the meeting complied with the **Open Meeting Act**. Tammy Belinson answered affirmatively.

After the reading of the minutes of the regular meeting of **January 8, 2019** and there being no additions or corrections, Darry Stacy moved that the minutes be **approved**. Greg Mashburn seconded the motion.

The vote was: Dave Stockwell, yes; Darry Stacy, yes; Tammy Belinson, yes; Sheriff Todd Gibson, yes; Greg Mashburn, yes; Judge Jeff Virgin, yes; Woody Glass, yes. Motion carried.

(April 8, 2019 Meeting was canceled due to lack of quorum.)

A. Items of Business:

1. Chairman Stockwell called for discussion and/or action to approve for fiscal year 2020 using up to \$5000 of 210 Administrative Fee Funds for GED testing fees, bus passes, AA/NA recognition items, housing deposits, tuition, other pro-social items, and 2 computers for participant use for actions such as job applications, GED preparation, computer training, and job searches.

Mr. Stockwell asked, "How was that done in the past for us?"

Deborah Cox said that everything has changed. Oklahoma County asked for an Attorney General opinion on how to do all of this. Now they want more participation in their plan. She sent them an email yesterday and they sent back a reply and didn't know if everyone had time to read the email. It is up to the members of the Board to decide what items they have used for through the year and assign a dollar amount to them and that's what they can use for the fiscal year. The extension is until August 14, 2019, and she printed a form they can use and she wrote a little wording at the top and they may redo it if they like and if it sounds right to leave as is. She needs them to tell her today how much to allocate for the use of these items if they want any of the items listed.

Chairman Stockwell said they should get a **motion** on the floor to **approve** and then discuss. He moved to **approve** the use up to \$5,000.00 in "210" money to benefit participants. Greg Mashburn seconded the motion.

Chairman Stockwell asked if they need a dollar amount on each item listed. Deborah Cox answered affirmatively and said that it is the total amount you will use for the year.

Chairman Stockwell asked if they are to complete the line items and do the math before rounding it up to \$5,000.00.

Deborah Cox said the \$5,000.00 need not be an exact amount, because at the top it tells how much is in their account. She cautioned that they shouldn't use it all in one year, but they can put whatever amount. She said they should not go over \$5,000 for each line item because anything over that amount has to go through the bid process.

Dave Stockwell said he didn't think they had enough time or ability to put dollar amounts to each line item. For instance, he did not know what the recognition coin cost is or how to apply a dollar amount in that category.

Deborah Cox said that it is still the same as when they did a blanket amount for everything. Now, they want specific information. She used as an example, drug testing supplies, to prepare for \$4,000 per year and recognition items, AA/NA, allocate anywhere from \$100 to \$1,000.

Dave Stockwell asked for the amount used in the past.

Deborah Cox said that in the past it was around \$4,000.00 and that amount proved correct.

Dave Stockwell asked for the number of people in Community Sentencing.

Deborah Cox said at present there are (58) fifty-eight people.

Darry Stacy asked, "Can we make a motion to sign a maximum amount and authorize each up to an 'X' amount of dollars?"

Dave Stockwell said that it is fine if they can do that and withdrew his motion.

Greg Mashburn withdrew his second.

Deborah Cox said that they can do \$20,000 to \$25,000.00.

Darry Stacy moved to the use of a maximum of \$25,000.00 and distribute as the coordinator sees fit.

Chairman Stockwell seconded the motion.

The vote was: Dave Stockwell, yes; Darry Stacy, yes; Tammy Belinson, yes; Sheriff Todd Gibson, yes; Greg Mashburn, yes; Judge Jeff Virgin, yes; Woody Glass, yes.

Motion carried.

2. Upon the recommendation of Deborah Cox, Chairman Stockwell moved, to strike the following item from the agenda:

"Discussion and/or action to approve for the fiscal year **2020** using up to \$4000 of 210 Administrative Fee Funds for the purchase of drug testing supplies." The vote was: Dave Stockwell, yes; Darry Stacy, yes; Tammy Belinson, yes; Sheriff Todd Gibson, yes; Greg Mashburn, yes; Judge Jeff Virgin, yes; Woody Glass, yes.

Motion carried.

3. Chairman Stockwell called for the **review of bills** for January, February, March, April, May and June 2019. He said that they didn't have a quorum last time and that is why they are doing six months this time. He asked, "On the mileage of 280 in November, what is that?"

Deborah Cox said that is where court-related services transported people to inpatient treatment. They have a contract where they can get paid for mileage.

Dave Stockwell asked if the Sheriff was getting all of his money.

Sheriff Todd Gibson answered affirmatively.

Chairman Stockwell moved, seconded by Greg Mashburn, to approve the bills for the first six months of 2019.

The vote was: Dave Stockwell, yes; Darry Stacy, yes; Tammy Belinson, yes; Sheriff Todd Gibson, yes; Greg Mashburn, yes; Judge Jeff Virgin, yes; Woody Glass, yes.

Motion carried.

4. Thomas Sasser, Assistant District Attorney, presented a report on January, February, March, April, May and June 2019 activity of Community Sentencing in the District Attorney's Office. They had 6 LSI ordered for the past quarter and they had three to plea in the program. They are having that continual plunging trend with all the other felony diversion courts in Cleveland County at this moment. He has spoken with the coordinator and their treatment team and it is his hope that with the Offender Screening Program and with Community Sentencing being included in that they will be able to capture the larger amount of population of people and distribute them more evenly as to what comes across the different courts according to what is proper and added that may increase their numbers. Lower felony fines are leading to a decrease.

Chairman Stockwell asked Greg Mashburn what trend he is seeing statewide. Greg Mashburn said that he is seeing a lot of the same. The drug courts normally would have 25 people and now they are down to 7. They don't have the numbers to keep going. The Drug Court contract reduced because numbers were down. They only gave them money for the real numbers they were putting in and so they are just continuing to see that and he is sure all that SQ 781 money they've been waiting on will get put back into the county, any minute now. Deborah Cox said that for the rest of her counties, she is seeing growth. She has not

Deborah Cox said that for the rest of her counties, she is seeing growth. She has not seen a downturn in Community Sentencing but has seen a decrease in Drug Court.

Chairman Stockwell said they have tried for 17 years to get 100 people on the program.

 Quarterly, P.O. requests additional NCIC reports to ensure that the client has not been arrested in another town or state.
