



COMMUNITY CORRECTIONS PLANNING COUNCIL

MINUTES

TUESDAY, OCTOBER 08, 2019

The regularly scheduled meeting of the Community Corrections Planning Council was called to order at 8:30 am this 8th day of October 2019 in the Conference Room 200 of the Cleveland County Office Building by Chairman Dave Stockwell. Linda Atkins, Deputy County Clerk/Secretary, called the roll and those present were:

Others present were: Linda Atkins, Greg Stroud, Deborah Cox, and Dawn Thatcher.

Chairman Dave Stockwell asked if the meeting complied with the **Open Meeting Act**. Linda Atkins answered affirmatively.

After the reading of the minutes of the regular meeting of **July 9, 2019**, and there being no additions or corrections, Darry Stacy moved that the minutes be **approved**.

Greg Mashburn seconded the motion.

The vote was: Dave Stockwell, yes; Darry Stacy, yes; Greg Mashburn, yes; Judge Jeff Virgin, yes; Woody Glass, yes.

Motion carried.

A. Items of Business:

1. Chairman Stockwell called for the **Review of bills** for the months of July, August, and September 2019. Debi Cox discussed that they have a total of \$78,000 for this year which is down; it used to be \$133,000 to \$140,000.

Dave Stockwell moved to **approve** the bills for the months as listed. Greg Mashburn seconded the motion.

2. Greg Mashburn said that Thomas Sasser is in Missouri for a conference and is not available to do the **Presentation by Assistant District Attorney** on the months of July, August, and September 2019 activity of Community Sentencing in the District Attorney's Office.

Chairman Stockwell said since they are on this topic he will ask Debi Cox to report on how things are going in surrounding counties.

Debi said they have 7 active now and have had 6 LSI since July 1st and for comparison purposes, McClain County has had 9 and Comanche County has had 25 more.

Chairman Stockwell asked what is going on statewide.

Debi Cox said that she is seeing tremendous growth and hasn't heard any local administrators say they have had decreases. She said they are working on growth now; however, Cleveland County has not had a lot of growth since July.

Chairman Stockwell asked how this compares with last year.

Debi Cox said that last year they ended with 58 and 29 pled in.

Chairman Stockwell said he did not know what they are going to do about this. A discussion was had about an evaluation form consisting of ten questions.

Chairman Stockwell said that it qualifies in place of something else and it gets them in and looked at faster, but from a defense attorney perspective, he does not like the program. He said that the jailers are not taking the time to go over this form with all the felons booked into jail between the hours of 5:00 pm to 7:00 am. He may meet with the Sheriff about policy and procedure on this.

Greg Mashburn said that a psychologist sent him a study saying that the questionnaire was not a good tool to use because it doesn't provide enough information.

Chairman Stockwell said that it consists of ten questions that take three minutes to do.

Greg Mashburn said that it is a start and provides some information.

Chairman Stockwell said that if it were him completing the form it would be all positive to get out of jail as quickly as possible.

3. **Greg Stroud presented a Supervision overview and absconder status report** by Court Related Services. He said that they had a graduate come back to donate some bikes to their program to express his gratitude to Community Sentencing for helping him.




