Chairman Blanton called for old business, discussion, consideration, and/or action on the following Letter of Protest:

Chairman Blanton inquired about the Stanley's. Dorinda Harvey, County Clerk/Secretary stated she had not heard anything, (she did received a telephone call prior to the last meeting that Mr. Stanley had been called out on military maneuvers).

Stacey Bridgers stated she was here to represent Cimmarron Gathering, and Ms. Harvey inquired if she had a letter from the Company stating that. Ms. Bridgers stated she didn't but she was with Tierra Property Tax Consultants and she is one of their consultants.

Denise Heavner, County Assessor, stated she didn't have any problem with that and that Ms. Bridgers is with that company and they have the authorization to represent Cimmarron Gathering, L. P.

Ms. Bridgers stated they are still awaiting a Supreme Court decision for 2005 values and the 2006 are being protested.

Chairman Blanton stated he did not see any action to take.

Denise Heavner stated she was aware there was an appeal to the lawsuit that the counties were successful with and they are waiting the appeal. The lawsuit covers several years and whatever decision is made Ms. Heavner assumes it will cover the entire time including this year.
