Chairman Blanton called for the discussion, consideration, and/or action to approve or disapprove amendments to the Estimate of Needs for Fiscal Year 2007-2008.

Vicki Wilson, County Budget Maker, addressed this Board on this item. Ms. Wilson explained she had explained this to the Budget Board and when she prepared the Estimates of Needs last year; she did not include the transfers in and out of the departments, which resulted in some of the departments looking like they were over stated just on the Estimate of Needs. On the actual records no one had over spent on any line item and all the records are correct. The State Auditor's Office wants an approved corrected copy with the transfers in it. David Batton, Assistant District Attorney, agreed with Ms. Wilson and recommended to the Board to approve the corrected copy of the Estimate of Needs to be filed with the State Auditor's Office.
