EXCISE BOARD OF CLEVELAND COUNTY Minutes

February 28, 2013

The regularly scheduled meeting of the Cleveland County Excise Board was called to order at 8:30 am this 28th day of February 2013, in the conference room of the Cleveland County Office Building by Chairman Waldo Blanton. Tammy Belinson, County Clerk/Secretary, called roll and those present were:
