Motion carried.



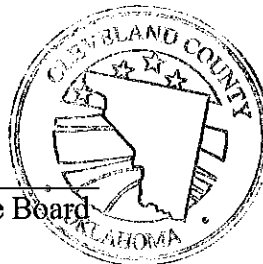
