Motion carried.



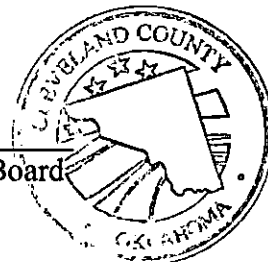
