



EXCISE BOARD OF CLEVELAND COUNTY

MINUTES

AUGUST 30, 2018

The scheduled regular meeting of the Cleveland County Excise Board was called to order at 11:00 a.m. this 30th day of August 2018 in meeting Room 200 of the Cleveland County Office Building by Chairman Larry Heikkila. Tammy Belinson, County Clerk/Secretary, called roll and those present were:

After the reading of the minutes of the Regular Meeting of July 26, 2018 and there being no additions or corrections, Waldo Blanton moved that the minutes be **approved**. Larry Heikkila seconded the motion.

Motion carried.

A. Items of Business:

1. Waldo Blanton moved to **accept** the 2018 Cleveland County Valuations as certified by Douglas Warr, County Assessor. Larry Heikkila seconded the motion. Douglas Warr addressed the Board by saying that the 2018 Cleveland County Evaluation amount is about \$2,248,072,674.00. It reflects a 4% increase in evaluation from last year and requested that these figures be accepted. The vote was: Larry Heikkila, yes; Waldo Blanton, yes; Charles Thompson, yes. Motion carried.

B. No **new business** was presented to the Board for discussion.

C. During **Board Members** discussions regarding County Business, Douglas Warr took a moment to recognize Russell Chronister, Deputy Assessor, for his hard work in preparing the 2018 Cleveland County Valuations report. He said Russell is a great asset to his office.

Chairman Heikkila agreed that, as citizens, it is a great privilege to have folks that work for the county possessing such a high level of integrity and ability to do the county's business; and most of all to trust the staff is truly a wonderful thing.


D. No **comments** from the public were made.


