MINUTES

AUGUST 29, 2019

The scheduled regular meeting of the Cleveland County Excise Board was called to order at 11:00 a.m. this 29th day of August 2019 in meeting Room 200 of the Cleveland County Office Building by Chairman Larry Heikkila. Linda Atkins, Deputy County Clerk/Secretary, called roll and those present were:

After the reading of the minutes of the Regular Meeting of July 25, 2019 and there being no additions or corrections, Charles Thompson moved that the minutes be **approved**. Larry Heikkila seconded the motion.

A. Items of Business:

1. Charles Thompson moved to **accept** the 2019 Cleveland County Valuations as certified by Douglas Warr, County Assessor. Larry Heikkila seconded the motion. Douglas Warr addressed the Board by saying that the 2019 County Evaluation amount is \$2,334,944,636. It reflects an overall county growth from last year of 3.86% and requested that these figures be accepted.

2. Larry Heikkila moved, seconded by Charles Thompson, to **accept the Notification of error correction** to the Excise Board from the County Sheriff's Department on the following:

(Request for Transfer within a Department under authority of 62 Okl.St. Ann. § 461.)

a. **Transfer** of funds from **CFBRE2-300**, Sheriff Revolving M & O, \$43,833.63 to Cleveland Commissioners **HWY Unrestricted**, \$43,833.63; and

b. **Transfer** of funds from **SHE1A** Sheriff General Fund Personal, \$550.00 to **CFB2** Sheriff Service Fee M & O, \$550.00.

The vote was: Larry Heikkila, yes; Charles Thompson, yes.

Motion carried.

B. No **new business** was presented to the Board for discussion.

C. No **discussion** was had by the **Board Members** regarding **County Business**.

D. No **comments** from the public were made.

E. There being no further business to come before the Board, Larry Heikkila moved that the meeting be **adjourned** at 11:10 am. The motion was seconded by Charles Thompson.
