MINUTES

OCTOBER 09, 2019

The scheduled **special** meeting of the Cleveland County Excise Board was called to order at **3:30 p.m.** this 9th day of October 2019 in meeting Room 200 of the Cleveland County Office Building by Chairman Larry Heikkila. Tammy Belinson, County Clerk/Secretary, called roll and those present were:

A. Old Business:

1. Chairman Heikkila called for **discussion, consideration, and/or action on Certification of Tax Levies for FY2019/2020.**

Tammy Belinson presented the **2020 Tax Levies** and all the joint county levies and all the schools and cities. She gave them three original copies ready for their signatures. She explained that once signed, she will file them with the State and then it gives the County Treasurer's Office the authority to type in those levy amounts and start collecting.

Larry Heikkila moved to approve the **Certification of Tax Levies for FY2019/2020.** Sid Porter seconded the motion.

The vote was: Larry Heikkila, yes; Sid Porter, yes.

Motion carried.

2. Chairman Heikkila called for **discussion and/or approval of FY 2019-2020 Budgets.**

Tammy Belinson presented the budgets for Cleveland County; Noble EMS; Norman Public Schools I-29; City of Norman; Lexington Public Schools I-57; Cleveland County Health Department; Little Axe Fire District; and Cedar Country Fire Protection District.

She said that the Board signed the following budgets at the last Excise Board Meeting on September 26, 2019: Little Axe Schools I-70; Moore Public Schools I-2; City of Noble; City of Moore; Noble Public Schools I-40; and Robin Hill Public Schools C-16.

Larry Heikkila moved to **approve** the **FY 2019-2020 Budgets** as presented by the County Clerk: Cleveland County; Noble EMS; Norman Public Schools I-29; City of Norman; Lexington Public Schools I-57; Cleveland County Health Department; Little Axe Fire District; and Cedar Country Fire Protection District.

Sid Porter seconded the motion.


The vote was: Larry Heikkila, yes; Sid Porter, yes.
