MINUTES

DECEMBER 26, 2013

The regularly scheduled meeting of the Cleveland County Tax Rolls Correction Board was called to order at 8:45 a.m. this 26th day of December 2013, in the meeting Room 200 of the County Office Building by Chairman Rusty Sullivan. Linda Atkins, Deputy County Clerk/Secretary, called roll and those present were:

After the reading of the minutes of the Regular Meeting of November 27, 2013 and there being no additions or corrections, Waldo Blanton moved that the minutes be approved. The motion was seconded by David Tinsley.

A. Items of Business:

1. Discussion, Consideration, and/or Action on Complaints of Erroneous Assessment and Orders of Correction as follows:

Chairman Sullivan asked Ms. Lankister if she would like to address the Board regarding the following:

David Tinsley said this is an exemption for a non-profit agency, and was in the building as of January 1, 2013. He said that his office did not know that, until she brought that to their attention. At that point, they made adjustments. He recommended changing it to "as entered".

Assistant District Attorney Heather Darby said that they must use it as a rectory to receive the charitable exemption.

Rusty Sullivan moved, seconded by Waldo Blanton, to table this item in order to contact them to find out more information on this.

David Tinsley said that they are not necessarily exempt through ownership alone.

Waldo Blanton said that they could be renting it out.

Rusty Sullivan said that the Board should give them an opportunity to get back with the Board if they are using it for a rectory.

David Tinsley said that it was previously used as a residential property. Rusty Sullivan moved, seconded by Waldo Blanton, to table further discussion and/or action on the following Complaint of erroneous Assessment and Orders of Correction:

Ralph Sparks said he was here to explain that half of the building is leased out and the other half of the building has no improvements. It has no studs in the wall, no equipment of any kind. He said that one area is considered Suite A and the other is Suite B. He said that he will contact the Assessor's office when it is leased. The assessed value increased from \$7,034.36 to \$9,274.62. David Tinsley said that they did make a change based on the fact that it wasn't finished.

Dowell stated that he has told Mr. Tinsley that the county should erect a statue in his honor because he has over paid about \$25,000.00 in the last five years. He said, "I guess if that is what it is, that is what it is. The law is the law."

Chairman Sullivan asked Assistant District Attorney Heather Darby to respond.

Ms. Darby said that the District Attorney's office did some research and found that according to the Statutes and Constitution it prohibits the Assessor's office from going back more than a year to get an exemption. Chairman Sullivan repeated, "The law is the law."

Rudy Khouri said that the reason they are asking for a tax exemption on this property is because the Church owns the house for use as a rectory for the priest.

Chairman Sullivan asked what the status of the home is now.

Mr. Khouri said that remodeling is in the process.

David Tinsley presented this question to the Board for consideration; if remodeling is going on with the house should it be tax exempt.

Mr. Khouri said that the property was purchased at the beginning of the year, but he didn't know the exact date. He said that it has sat vacant all this time. The remodel started about a month and a half ago.

After a brief discussion, Assistant District Attorney Heather Darby stated that she will check into the legalities of the application for tax exemption. David Tinsley recommended that Mr. Khouri pay one-half of the taxes, pending the District Attorney's Office decision for an adjustment to the correct amount. A reimbursement will be given, if the decision is that it is tax exempt. Mr. Khouri said that is agreeable with him.

Upon the recommendation of County Assessor David Tinsley, Rusty Sullivan moved to approve the exemption with it hinging on what is found out legally on this piece of property and that it is adjusted from that point.
