TAX ROLL CORRECTION BOARD

MINUTES

JULY 31, 2014

The regularly scheduled meeting of the Cleveland County Tax Roll Correction Board was called to order at 8:45 a.m. this 31st day of July 2014 in meeting Room 200 of the Cleveland County Office Building by Chairman Darry Stacy. He paid a tax bill amounting to \$171.88 plus fees that amounted to \$300.00. He is contesting for 2013's original tax bill realizing that the fees are non-refundable. They never had capital assets in the building. The space was empty and used by bands to rehearse.

She works alone with used equipment. Ms. Jackson stated that for the past 20 years she has done hair. She is here to see if she can get a correction on the fine according to what the County Assessor thought she had in the salon. She corrected her address so all business mail is now coming to her home address. She paid the taxes and the fine until she could come to present this to the Board for its consideration.

Assistant District Attorney Heather Darby said that penalty fees are non-refundable.

Chairman Stacy recommended that she contact the Assessor's office to do a corrected 901 form.

Ericka Jackson said that she did list everything in detail. She said that the value of the equipment in the salon is less than \$500.00.

David Tinsley said that adjustments for 2014 were done, but is not sure about 2013.
