### **MINUTES**

# **SEPTEMBER 24, 2015**

The regularly scheduled meeting of the Cleveland County Tax Roll Correction Board was called to order at 8:45 a.m. this 24<sup>th</sup> day of September 2015 in meeting Room 200 of the Cleveland County Office Building by Chairman Rod Cleveland.
