

# TAX ROLL CORRECTION BOARD

## MINUTES

JULY 28, 2016

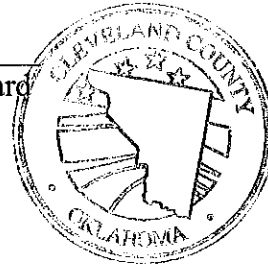
