2. Action on Complaints of Erroneous Assessment and Orders of Correction,
as follows:

Chairman Haralson called for discussion on No. 34074 – Reginald Jaime. David Tinsley said that this is a situation where a partial property sold and so the cap came off and then after it sold the people found out that they had to spend a huge amount of money to put in a road. So he decided to just take the property back and they rescinded the deed.

Mr. Jaime explained that he inherited 14 acres from his parents which he sold on November 2015. The buyer could not get a building permit from the City of Norman to build a home so he returned the money to the buyer. He is asking for undeveloped land status once more.

Chairman Haralson asked, “So you basically want it to go back like it was before?”

Mr. Jaime said that is correct.

David Tinsley said that recorded as sold meant that the cap came off, which caused the problem.

Assistant District Attorney Heather Darby advised that it could return to its former assessment as undeveloped land.

He said that this is a new owner mistake on the personal property on leased equipment. The Equipment Company said they were collecting for all their personal property tax to pay in. He didn't know that he was to assess and pay in as well. He failed to assess and figure that out. He has since submitted the corrections where they were paying and then he included some other things like a computer, a couch and a table. He said most of the taxes are paid. All he is asking is to get it corrected to show that the company did pay the bulk of the taxes and whatever is left over they will pay. David Tinsley asked Mr. Lynn about his inventory.

Kelly Lynn said that they don't keep an inventory other than display shirts in a showroom window. They do custom clothes which means they order the clothes for the specific project. The order is shipped to them overnight, and then they print the clothes. From that point the clothes are shipped out immediately to the customer. No stock is kept on inventory.

Doug Warr, Deputy County Assessor, said that they would gladly do an audit and inspection of the business to make sure that everything is correct.


