

## TAX ROLL CORRECTION BOARD

### MINUTES

MAY 25, 2017

The regularly scheduled meeting of the Cleveland County Tax Roll Correction Board was called to order at 9:00 a.m. this 25th day of May 2017 in meeting Room 200 of the Cleveland County Office Building by Chairman Harold Haralson. Linda Atkins, Deputy County Clerk/Secretary, called roll and those present were:

Others present were: Assistant District Attorney Jim Robertson, Linda Atkins, Doug Warr, Kayla Putman, Kelly Butts, Diane Dye, Laquita Farmer and Alisse Ellis.

After the reading of the minutes of the Regular Meeting of April 27, 2017 and there being no additions or corrections, Waldo Blanton moved that the minutes be approved. David Tinsley seconded the motion.

#### **A. Items of Business:**

##### **1. Action on Complaints of Erroneous Assessment and Orders of Correction as follows:**

Assistant District Attorney Jim Robertson introduced Alisse Ellis which is here to represent Harmony Hardware & Home and has no documents to support her case.

Chairman Haralson asked if this needs tabling until the Board receives proper evidence.

Alisse Ellis said that she sent in documents to the County Assessor's Office and was under the impression it was not necessary to bring anything to the meeting.

David Tinsley said he received a letter from an April Sexton.

Alisse Ellis said that there is another company in her office and added that they run several companies from their office. She said that there is proof from the Secretary of State that they are inactive and with the Oklahoma Tax Commission. She went on to define that Harmony Hardware was not an actual store front business, they have Brent Swift Designs that used the Harmony Hardware for supply fixtures, bathtubs and plumbing for clients. There is no longer a Harmony Hardware; everything is through Deck Works.

David Tinsley asked if there is inventory connected to Harmony Hardware. Alisse Ellis said that they made orders on a need be basis. She said that a previous Tax Accountant recommended that they incorporate Harmony

Hardware fifteen years ago and the new Tax Accountant advised that it is not necessary to do it that way and now, it is Deck Works. Doug Warr, Deputy County Assessor, said that they rendered the assets under Deck Works and recommended that the Assessor's office investigate for duplication and asked for time to check.

Waldo Blanton moved, seconded by David Tinsley, to **table** the following item until the next regularly scheduled meeting on Thursday, June 29, 2017.

Assistant District Attorney Jim Robertson stated that his notes show that they closed in 2015 and moved to Oklahoma County. Oklahoma County has the 2017, but not the 2016. He asked Ms. Farmer if she had proof of the closure today.

Laquita Farmer said, "I didn't close, I moved."

Legal Counsel asked, "Can you prove when you moved to Oklahoma County?"

Ms. Farmer said that she will provide electric bills and the lease agreement for the new building.

David Tinsley asked for the 901 Form that she turned into Oklahoma County for 2016.

Ms. Farmer indicated that she may have that form at the center, but not with her today. She said that a tax bill from Oklahoma County 2016 is still pending.

David Tinsley asked, "Did you render to Oklahoma County for 2016?"

Laquita Farmer replied that she assumed they knew after purchasing a City License for the Beyond Learning Child Care.

David Tinsley said that the City does not communicate information to the County.

Laquita Farmer said she didn't think it was necessary, because when she moved to Cleveland County she didn't contact the County Assessor's Office either. She received a bill for personal property taxes in the mail.

David Tinsley said, "We probably discovered that your business was open and apparently Oklahoma County hasn't."

Doug Warr said that his office visited with Oklahoma County and then spoke with Ms. Farmer that each year she is to render a list of all her assets on a 901 Form. He said the Assessor's office did an arbitrary assessment of the business because there is no listing of true assets.

David Tinsley recommended that she furnish the 901 Form for 2016 from Oklahoma County and then the Assessor's office will remove it from the Cleveland County Tax Roll.




